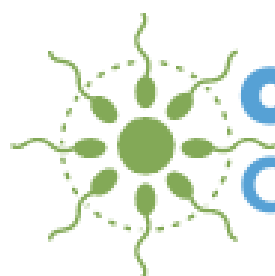

ABOUT THE CONFERENCE

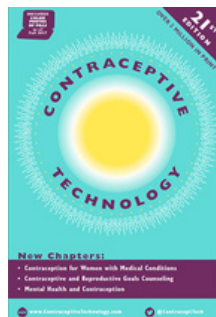
